Notification

In exercise of power conferred under proviso of schedule -309 of the constitution of India, the Governor of Bihar is pleased to make the following rules to regulate the appointment, promotion and service Conditions of Bihar Agriculture Subordinate, Service category - 3 (Chemistry).

1. Short title, name, extent and commencement:-

- (i) These rules shall be called Bihar Agriculture subordinate service category -3 (Chemistry) Rules -2014.
- (ii) It shall extend to the whole of state of Bihar.
- (iii) It shall come into force at once .

2. Definition:- In these Rules, unless other wise requires in the context.

- (i) "Department" means Agriculture Department of the Government of Bihar
- (ii) "Cadre" means cadre of Bihar Agriculture Subordinate Service category -3 (Chemistry)
- (iii) " Commission" means Bihar Staff Selection Commission.
- (iv) "Year" means " financial year" i.e. from 1st April to 31st March of next year .
- (v) "Member" means person appointed under Bihar Agriculture Subordinate Service, category-3 (Chemistry).
- (vi) "Appointing Authority" means Agriculture Director, Agriculture Department.

3 Constitution of cadre and hierarchy

This shall be a state Service and Agriculture department shall be its administrative department.

- (1) Assistant Research officer shall be the basic grade post of this cadre.
- (2) The department may review the structure and strength of cadre as per need.

4 Appointment in basic category -

- (1) Post of basic category shall be filled up by direct appointment.
- (2) The calculation of vacant posts for direct appointment against the sanctioned posts of cadre, shall be made on the basis of on 1st April every year and by 30th April the appointing authority shall send requisition reservation category wise to the Commission.
- (3) Academic Qualification- Graduation in Agriculture Science from recognized Agriculture University or institution/ Central University or Graduation in chemistry from a recognized University .

(4) **Direct Appointment.**

- (a) Direct appointment shall be made from amongst the candidates recommended on the basis of Competitive Examination conducted by the Commission.
- (b) Age limit – minimum age shall be 21 (twenty one) years on 1st April of the year inviting the application and maximum age limit shall be the same as may be determined from time to time, by the Department of General Administration for direct appointment in the services of the state but in special circumstances, the department may increase it recording reasons for the same.
- (c) Reservation- The provisions for reservation determined by the Department of General Administration, from time to time for direct appointment in the services of state, shall apply .
- (d) For direct appointment, requisition along with number of general and category wise vacancies shall be sent to the commission every year by the Department.
- (e) Subjects any syllabus of Competitive Examination There shall be following Papers in the Competitive Examination .
- (i) General Hindi – 100 Marks
- (ii) General Knowledge – 100 Marks
- (iii) Agriculture Science / Chemistry-

Two papers carrying 200 marks each
total 400 marks .

(There shall be two papers of graduation level. Carrying 200 marks each, separately for the candidates of Agriculture Science and chemistry).

It shall be compulsory to obtain 30 percent marks in Hindi but the marks obtained in this paper shall not be calculated for the purpose of preparation of merit list. The merit list shall be prepared on the basis of total marks obtained out of 400 marks in Agriculture Science / Chemistry and 100 marks of General Knowledge. The Syllabus for Hindi and General Knowledge shall be the same as may be determined by the Bihar Staff Selection Commission for the Joint Competitive Examination conducted by it. The syllabus for Agriculture science / Chemistry, shall be prepared by the department in consultation with commission.

- (f) Recommendation of candidates by the Commission – The Commission shall prepare merit list reserved category wise on the basis of marks obtained in the examination conducted by the Commission and shall send recommendation to the department according to the reported vacancies.

5 Probation –

- (1) Every member appointed by direct recruitment in the service , shall be on probation for the period of 2 years from the date of his Joining but in special circumstances, this period may be extended up-to one year recording the reasons. If in the said extended period also his performance is not satisfactory, he may be terminated from his services, by the Government, without asking any show cause , but he shall be given its written notice with reasons.
