In exercise of power conferred under proviso to Article 309 of the Constitution of India, the Governor of Bihar, is hereby pleased to make the following rules to regulate the appointment, promotion and service-conditions in the Bihar Agriculture Service Category-5 (Plant Protection):-

**1. Short title, extent and commencement:-**

- (1) These rules may be called Bihar Agriculture Service Category-5 (Plant Protection) cadre (Appointment, Promotion and Service Conditions) Rules, 2014
- (2) It shall extend to the whole of the State of Bihar
- (3) It shall come into force with publication of notification.

**2. Definition:-** In these rules, unless otherwise is required in the context-

- (i) **"State"** means the State of Bihar;
- (ii) **"Governor"** means the Governor of Bihar;
- (iii) **"Government"** means Government of Bihar;
- (iv) **"Department"** means Agriculture Department of Bihar;
- (v) **"Agriculture Service Act"** means Bihar Agriculture Service Act, 1982 (Bihar Act no. 44, 1982);
- (vi) **Category-5 (Plant Protection)** means Category-5 Plant Protection mentioned under schedule -1 of section 2 of Bihar Agriculture Service Act, 1982;
- (vii) **Bihar Agriculture Service Category-5** means Agriculture Service means Agriculture Service Category-5 of the State of Bihar;

- (viii) **“Cadre”** means cadre of Bihar Agriculture Service category- Category-5 (Plant Protection)
- (ix) **“Commission”** means “Bihar Public Service Commission;
- (x) **“year”** means Financial year viz period from 1st April to 31<sup>st</sup> March of the next year.
- (xi) **“Competent Authority”** means Authority declared by Rules of Executive Business.
- (xii) **“Member”** means person appointed under Bihar Agriculture Service Category-5 (Plant Protection)
- (xiii) **Appointing Authority** means Government of Bihar;

**3. Cadre Control-** This shall be a state service and Agriculture Department shall be its controlling Department.

**4. Hierarchy-**

(1)-(a) Hierarchy shall be following:- Post of basic category: Assistant Director ((Plant Protection)

(b) First promotional post:- Deputy Director (Plant Protection).

(c) Second promotional post: Joint Director (Plant Protection)

(d) Third promotional post: Additional Director (Plant Protection)

2- Structure and strength of the cadre shall be reviewed, and salary shall be decided by the Government.

**5. Appointment and promotion in the basic category-**

- (1) It shall be obligatory for the candidate to be a citizen of India, for the appointment in the service. 67 percent posts of the basic category shall be filled by direct appointment and 33 percent posts shall be filled up by promotion.
- (2) The calculation of vacant posts for promotion and direct appointment, against the
