In exercise of Power conferred under Proviso of Schedule -309 of the constitution of India, the Governor of Bihar is pleased to make the following rules to regulate the appointment, promotion and service conditions of Bihar Agriculture Sub- Ordinate Service, Category -8 (Weights and Measures):-

1. Short title, name, extent and commencement

- i. These rules shall be called Bihar Agriculture Subordinate Service, category -8 (Weights and Measures) Rules -2014 .
- ii. It shall extend to the whole of the State of Bihar.
- iii. It shall come in to force at once.

2. Definition:- In these Rules, unless otherwise requires in the context.

- i. "Department" means Agriculture Department of the Government of Bihar.
- ii. "Cadre" means cadre of Bihar Agriculture Sub- Ordinate Service category -8 (Weights and Measures).
- iii.. "Commission" means Bihar Staff Selection Commission.
- iv. "Year" means Financial year i.e. from 1st April to 31st March of next year".
- v. "Member" means person appointed under Bihar Agriculture Subordinate Service, Category -8 (Weights and Measures).
- vi. "Appointing Authority" means Agriculture Director, Bihar, Patna.

3. Constitution of Cadre. :-

- 1 This shall be a state Service and Agriculture Department shall be its administrative Department.
- 2 Inspector, Weights and Measures shall be the basic post and its hierarchy of promotion shall be in the following manner:
 - (a) Inspector Weights and measure- basic grade post of this cadre.
 - (b) Assistant Controller – Weights and Measures – 1st Stage (of Promotion).
 - (c) Deputy controller – Weights and Measures – IInd Stage (of Promotion
 - (d) Joint Controller Weights and Measures – IIIrd stage (of promotion).
- 3 The department may review the structure and strength of the cadre as per need.
- 4 The Pay scale fixed by the Government , shall be admissible for the aforesaid post.

4. Appointment in basic category :-

1. Posts of basic category shall be filled up by direct appointment.
2. The calculation of vacant posts for direct appointment against the sanctioned post of cadre, shall be made on the basis of 1st April every year.

(3) Academic Qualification :-

Minimum academic qualification for direct appointment to the posts of basic grade in the cadre shall be graduation in science with physics / Engineering/ Technology, from recognized University / Institute.

(4). Direct Appointment :-

- (a) Direct appointment shall be made from amongst the candidates recommended on the basis of Competitive Examination conducted by the Commission.

(b) Age Limit :-

Minimum aged shall be 21 (Twenty one) years on 1st April of the inviting the application and maximum age shall be the same as may be determined from time to time by the Department of General Administration for direct appointment in the Services of the State but in special circumstances, the department may increase it recording reasons for the same.

- (c) **Reservation :-** The provisions for reservation determined by the Department of General Administration, from time to time, for direct appointment in the services of the state, shall apply.

- (d) For direct appointment, requisition along with number of general and category wise vacancies shall be sent to the commission every year by the Department.

- (e) **Subjects and syllabus of Competitive Examination :-** There shall be following papers in the Competitive Examination:-

- (i) General Hindi – 100 Marks (One paper)
- (ii) General Knowledge – 100 Marks (One Paper) .
- (iii) Science (With physics)/ Engineering/ Technology .

Two Papers) carrying
200 Marks each
Total – 400 Marks.

It shall be compulsory to obtain 30 percent marks in Hindi but the marks obtained in this paper shall not be calculated for the purpose of preparation of merit list. The merit list shall be prepared on the basis of total marks obtained out of 400 marks in science (with physics) / Engineering/ Technology and the marks obtained
