Sub: Launch of Direct Benefit Transfer for LPG (DBTL) Scheme in Bihar.

We are glad to inform that Government of India have advised us to implement the Direct Benefit Transfer of LPG (DBTL) scheme in 54 identified districts in other states of the country from 15th November, 2014 and in rest of country including Bihar from 1.1.2015. In this regard, we are enclosing herewith the Press Release issued by Union Govt on 30.10.2014 as **Annexure-1**.

The salient features of the DBTL scheme are as follows:

1. All LPG consumers who join the DBTL scheme can receive LPG cash subsidy:
 - By linking Aadhaar number to the LPG and bank database as the primary option.
 - OR**
 - Directly into the bank account without linking it with Aadhaar as the secondary option.
2. All LPG consumers who have already joined the scheme solely based on Aadhaar number will start getting subsidy in their Aadhaar linked bank accounts after scheme is launched with effect from 01.01.2015.
3. LPG consumers will get a **Grace Period** of 3 months during which consumers who have joined the scheme will get subsidy in bank account and others will continue to get cylinders at subsidized price during this grace period.

4. LPG consumers who do not join the scheme after the 3 month grace period, will be eligible for an additional subsidy **Parking Period** of 3 months. During this period, LPG cylinders to all such consumers will be supplied at market price, but the subsidy due on all LPG supplies will be credited to the bank account as soon as consumer joins the scheme in this period and as per entitlement.
5. LPG consumers whoever newly joins the scheme in future will get a permanent advance equal to the fixed subsidy per cylinder towards the purchase of the first market priced cylinder.
6. This DBTL scheme will ensure that entitlement of LPG consumers is not diverted.

In this connection, Secretary, MOP&NG has written letters to Chief Secretaries of states of 54 districts where DBTL has been implemented from 15.11.2014. One such letter written by Secretary MOP&NG to Chief Secretary, Govt of AP is enclosed for kind reference (**Annexure-2**) wherein the scheme details are narrated. Hon'ble Minister of State (P&NG) has written letters to Chief Ministers of states of 54 districts where DBTL has been implemented from 15.11.2014. One such letter written by Hon'ble MOS(MOP&NG) to Chief Minister of AP is enclosed for kind reference (**Annexure-3**).

We are taking all preparatory steps from our side for implementation of the DBTL Scheme with effect from 01.01.2015. We request your kind help by taking up the matter with the DIOs, NIC and IT Department wings of all the districts and help us for smooth implementation of the scheme in the interest of domestic LPG consumers in Bihar.

Modified direct benefit transfer scheme to be relaunched in the country

The Union Cabinet, chaired by the Prime Minister Shri Narendra Modi, today approved the Modified Direct Benefit Transfer Scheme in LPG being re-launched in 54 districts from mid-November, 2014 and in rest of country from 1.1.15. The Cabinet has revisited the scheme design and processes and after thorough review, it has approved the Modified DBTL which will alleviate the hardships of the LPG consumers faced by them in the earlier scheme.

The salient features of the Modified DBTL scheme are as follows:

- The subsidy per domestic subsidized cylinder shall be fixed.
- All LPG consumers who join the modified DBTL scheme in future can receive LPG cash subsidy:
 - By linking Aadhaar number to the LPG and bank database as the primary option.
 - OR
 - Directly into the bank account without necessarily linking it with the use of Aadhaar as the secondary option.

This will ensure that no consumer is denied LPG subsidy for want of Aadhaar number.

- All LPG consumers who had already joined the scheme solely based on Aadhaar number will start getting subsidy in their Aadhaar linked bank accounts after scheme is launched.
- LPG consumers will get a **Grace Period** of 3 months during which consumers who have joined the scheme will get subsidy in bank account and others will continue to get cylinders at subsidized price.
- LPG consumers who do not join the scheme after the 3 month grace period, will be eligible for an additional subsidy **Parking Period** of 3 months. During this period, LPG cylinders to all such consumers will be supplied at market price, but the subsidy due on all LPG supplies will be credited to the bank account as soon as consumer joins the scheme in this period and as per entitlement.
- LPG consumers who will now join the modified scheme in future will get a permanent advance towards the purchase of the first market priced cylinder equal to the fixed subsidy per cylinder.
- A revamped grievance system to attend to consumer grievances will be put in place.

The Modified DBTL scheme will ensure that entitlement of LPG consumers is not diverted for ineligible purpose and public funds so saved can be utilized in nation building. LPG consumers are advised to join the scheme to protect their entitlement of subsidized cylinders.
