Pursuant to the earlier order dated 26.10.2016 apart from the complainant, Sri. Lalbabu Singh, Sri. Abhay Kumar, Superintending Engineer, Building Construction Circle, Building Construction Department, Bihar, Patna, Sri. Vikash Kumar, District Agriculture Officer, Headquarter, Bihar, Patna and Sri. Janak Ram, Deputy Secretary, Udyan Pramandal, Building Construction Department, Bihar, Patna, are also present.

In course of enquiry and hearing of this case a picquant situation has emerged inasmuch as the complainant denies either filing of his complaint on affidavit dated 06.09.2008 or the subsequent affidavit of complainant dated 08.04.2009 which was produced by Sri. Vikash Kumar, by way of his defence before the department in his explanations. The complainant asserts

that he is totally illiterate and had never put his signature in the complaint petition the aforesaid two affidavits and infact has always in his service career received even payment of his salary only by giving his thumb impression on the acquaintance role.

On the other hand, Sri. Vikash Kumar, has stated that the affidavit dated 08.04.2009 which was produced by him alongwith his show-cause reply/explanation contained signature on the affidavit of Sri. Lalbabu Singh, the complainant is his own signature and Sri. Lalbabu Singh is, therefore, making false statement that he had not put his signature on the affidavit dated 08.04.2009.

Under such circumstances, when the original records have been produced by the Superintending Engineer, Building Construction Circle, Building Construction Department, Bihar, Patna, it becomes necessary to hold further enquiry firstly with regard to bonafide of the complainant.

This Authority, would, therefore, firstly like to know as a matter of fact from the office of the Superintending Engineer, Building Construction Circle, Building Construction Department, Bihar, Patna, or from the Garden Division of Building Construction Department, Bihar, Patna, as to whether there is any documentary evidence to show that Sri. Lalbabu Singh, had drawn his salary and/or had got any other favour by putting his signature or as to whether he has all along been putting his thumb impression for receiving payment of salary and/or other allied purposes. Additionally, Sri. Lalbabu Singh also must file his explanation that he had neither filed this complaint nor sworn this two affidavits.

In the mean time, Sri. Vikash Kumar, also himself submit his explanation both in respect of the charges that was leveled by Sri. Lalbabu Singh in his original complaint petition as also with regard to the defence of Sri. Lalbabu Singh that he had never sworn any affidavit and that the affidavit produced by Sri. Vikash Kumar is true and correct.

The further enquiry and hearing of this case as a part heard and tied up mater shall take place on 13.02.2017 when all the officials present today as well as Sri. Lal Babu Singh and Sri. Vikash Kumar, must remain present with their reports and/or records.
